4. All "Verified Customer Sales" must be paid by the Privileged Customers on their own. If it is found that the payer is not the Privileged Customer, Amway will correct the order as "Non-Verified Customer Sales" and deduct the extra PV generated by the relevant order and bonuses.
5. Verified payment methods for orders in Macau Merchandising Centres include cash, credit card/UnionPay card with the name of the PC, MPay, Macau Pass, Alipay Macau, CGB Payment, Tai Fung Pay, UePay, LusoPay, Bank of China Macau and ICBC e-payment.
